# Readjustment Counseling Service

Readjustment counseling is a unique VA service authorized by 38 USC, section 1712A. As designed by Congress and implemented by VA in 1979.

Readjustment counseling is a non-medical counseling service designed to assist combat Veterans overcome all barriers to care. This service enables them to sufficiently achieve a successful post-war adjustment.

# Readjustment Counseling Service

VA Vet Centers are the service delivery sites for provision of readjustment counseling. Vet Centers are community-based facilities, located outside of the larger VA medical facilities, in easily accessible locations. Vet Centers are relatively small service units staffed by multidisciplinary teams consisting of:

- Team Leader
- Office Manager
- Three to four Counselors
- Outreach Specialist
- Mobile Vet Center Driver (Situational Dependent)\*

# Military Sexual Trauma

#### Overcoming military sexual trauma (Video) 3 min

MST is defined by Title 38 U.S. Code 1720D as "psychological trauma resulting from a physical assault of a sexual nature, battery of a sexual nature, or sexual harassment which occurred while the Veteran was serving on active duty, active duty for training, or inactive duty training." Sexual harassment is defined as "repeated, unsolicited verbal or physical contact of a sexual nature which is threatening in character."

# Stigma

#### "Public Stigma

- Stereotype Negative belief about a group(e.g., dangerousness, incompetence, character weakness)
- Prejudice Agreement with belief and /or negative emotional reaction (e.g. anger, fear)
- Discrimination Behavior response to prejudice (e.g., avoidance, withhold employment and housing opportunities, withhold help)

#### **Self Stigma**

- Stereotype Negative belief about self (e.g., character weakness, incompetence)
- Prejudice Agreement with belief, negative emotional reaction(e.g., low self esteem, low self efficacy)
- Discrimination Behavior response to prejudice (e.g., fails to pursue work and housing opportunities)"\*

# Its Impact on the Veteran

"Stigma yields 2 kinds of harm that may impede treatment participation: It diminishes selfesteem and robs people of social opportunities."\*

# Its Impact on the Veteran

"Self-stigma was associated with a decreased likelihood of using mental health services for both female and male Veterans....

Concern about public stigma from either loved ones or in the workplace did not predict use of mental health care for either female or male Veterans." \*

# Its Impact on the Veteran

"Attitudes such as toughness, mission focus, and self and group-based sufficiency are instilled in service members to ensure combat readiness.

This belief system contributes to the notion that help-seeking is a sign of weakness and that strong, self-reliant individuals can "tough out" any problem or injury."\*
