#### Social Work Ethics

- Code of Ethics of the National Association of Social Workers
  - Guides practice & decision making
  - Provides some consistency across profession
  - Distinguishes our profession from others
- Professional obligation of all social workers
- Legal obligation of all Missouri licensed social workers—at all levels

### Purpose of the NASW Code of Ethics

- The Code identifies core values on which social work's mission is based.
- The Code summarizes broad ethical principles that reflect the profession's core values and establishes a set of specific ethical standards that should be used to guide social work practice.
- The Code is designed to help social workers identify relevant considerations when professional obligations conflict or ethical uncertainties arise.

# Purpose of the NASW Code of Ethics continued

- The Code provides ethical standards to which the general public can hold the social work profession accountable.
- The Code socializes practitioners new to the field to social work's mission, values, ethical principles, and ethical standards.

# Purpose of the NASW Code of Ethics continued

 The Code articulates standards that the social work profession itself can use to assess whether social workers have engaged in unethical conduct. NASW has formal procedures to adjudicate ethics complaints filed against its members.\* In subscribing to this Code, social workers are required to cooperate in its implementation, participate in NASW adjudication proceedings, and abide by any NASW disciplinary rulings or sanctions based on it.

- 4.04 Dishonesty, Fraud, and Deception
- 4.06 Misrepresentation

### Most Frequent Ethical Issues before the Missouri State Board

- Boundary issues/dual relationships
- Failure to document properly

### Objective #2

#### ETHIC Model of Decision Making

- E Examine relevant values
- T Think about the code & relevant laws
- H Hypothesize about possible consequences
- I Identify who will benefit & be harmed
- C Consult with supervisor & colleagues

- Identify social work values separate from personal values
- Examine client values
- Societal values my be relevant
- Consider agency values

Examine relevant personal, societal, agency, client & professional values

Examine relevant values

#### NASW Code of Ethics

- Six sections of social worker's responsibility to
  - 1. Client
  - Colleagues
  - 3. Practice settings
  - 4. Professionals
  - 5. The profession
  - The broader society

Think about what ethical standard of the NASW code of ethics applies, was well as relevant laws & case decisions

Think about code & relevant laws

- Consider different scenarios of impact or decision
- List pros & cons of each potential scenario
- Examine possible results of each

Hypothesize about possible consequences of different decisions

Hypothesize about possible outcomes

- Sometimes have to decide between two bad alternatives
- Concern for most vulnerable is a hallmark of our profession

Identify who will benefit & who will be harmed in view of social work's commitment to the most vulnerable

Identify who will benefit & be harmed

- Others may suggest alternatives or present new information
- Should use supervisor as a first resource in ethical decision making
- Ethics committees can be helpful

C Consult with supervisors & colleagues about the most ethical choice

#### Avoiding Ethical Pitfalls

- Protect confidentiality
  - Discuss limits of confidentiality
  - Ensure safe storage of confidential records
  - Know federal & state laws
  - Obey mandatory reporting laws
- Respect autonomy & self-determination
- Know your supervisory responsibilities

### Avoiding Ethical Pitfalls cont.

- Identify your client & role
- Document
- Practice within scope of expertise
- Know the difference between abandonment & termination
- Understand what constitutes a dual relationship

#### Views on Dual Relationships

Should avoid dual relationships at all costs

- Dual relationships are situationally & contextually determined
- Being too dogmatic diminishes the essence & authenticity of social work practice

#### **Dual Relationships**

#### **Absolutist**

 Believe certain actions are ethically right or wrong & that certain values should always determine moral course of action

#### **Relativist**

- Believe that moral standards are personal, subjective, & situational
- Morality of a decision is measured by the goodness of the outcome

### **Dual Relationships**

#### **Always Wrong**

- Dating
- Bartering
- Business arrangements

#### Maybe Acceptable

- Social events in rural settings
- Attending funeral of hospice patient
- Providing service in only professional available

# Deciding about entering into a Dual Relationship

- How will the dual relationship change the power differential or take advantage of the power differential in the therapeutic relationship?
- How long will the dual relationship last?
- How will ending one relationship affect the other relationship?
- How much will objectivity be impacted?
- What is the risk of exploitation?
